- (c) A sum of Rs. 37.56 crore have been released during the last four years under revamped Central Road Funds (CRF) Scheme in Kerala.
- (d) and (e) The works on Calicut bypass Phase-Ill on NH-17 and Alappuzha bypass Phase-Il on NH-47 have been taken up. These are scheduled to be completed by March 2006 and June 2007 respectively.

## **Contractors working on Highways**

- 2512. SHRI V. HANUMANTHA RAO: Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:
- (a) whether it is a fact that contractors are supposed to display their names, addresses, ownership details and the cost of contract including the phone numbers of the offices all along the highways where they undertake work;
- (b) whether it is a fact that this demand was made by social activists two years ago to the NHAI in interest of transparency and knowledge;
  - (c) the objections of the NHAI is not agreeing to this demand;
- (d) what would NHAI gain by not allowing the public to know who the contractors are and what is the cost of the work and what they are supposed to do; and
  - (e) the steps proposed to be taken to concede to the demand?

## Damage of NH-31 and NH-107 due to floods

and NH-107 (Mahesh Khunt to Mali Chowk) in Khagaria district in Bihar have been damaged due to floods; and

- (b) if so, the steps being taken by Government to reconstruct the highways and by when it would be reconstructed and made operational?
- THE MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS (SHRI K. H. MUNIYAPPA): (a) The stretches from Mahesh Khunt to Mali Chowk on NH-107 and on NH-31 in Khagaria district have been damaged at various locations due to recent floods.
- (b) In Khagaria district temporary restoration work on the stretch of NH-31 has already been taken up by the Road Construction Department, Bihar. Restoration work in Mahesh Khunt- Mali Chowk section of NH-107 would be possible and National Highway made operational only after the floodwater recedes. For flood damage repair works on various National Highways in Bihar, Rs. 5.00 crore has been released to Bihar Government.
