- (b) The State of Karnataka has been provided with the funds for five districts namely Belgaum, Ramnagar, Tumkur, Chikkaballapur and Bengaluru Rural District for digitization of cadastral maps, survey and resurvey and establishment of modern record rooms. Out of the sanctioned central share of ₹ 4019.89 lakh, a sum of ₹ 2451.20 lakh was released during the year 2012-13. As per information available on MIS, Karnataka Government has spent ₹ 22.56 lakh against the released amount of ₹ 2451.20 lakhs. However, all the Record of Rights (RTC) land records in Karnataka are already digitized from the resources of State Government under the prestigious project "BHOOMI".
- (c) to (e) Government of Karnataka has not sent any proposal for other districts in this regard.
