

are required to have dedicated mentorship-cum-placement cells for industry linkage and placement of candidates. TPs are mandated to organize Placement/Rozgar Melas every six months with support from the SSCs and to ensure the participation of local industry. Additionally, there is also a provision to provide post placement support to candidates from special areas, women and PwDs for three months provided the placement is made within three months of certification and after post validation of placement of the candidate. The post placement financial support provided to PwD candidates is higher than that provided to the non-disabled candidates.

#### **Proactive skill development programmes**

626. KUMARI SELJA: Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

(a) whether Government proposes to make skill development programmes more proactive;

(b) if so, the details thereof; and

(c) the number of persons in Haryana who have availed the benefits of the said programmes so far, district-wise?

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI ANANTKUMAR HEGDE): (a) and (b) Ministry of Skill Development and Entrepreneurship is implementing flagship scheme known as Pradhan Mantri Kaushal Vikas Yojana (PMKVY) on pan-India basis for imparting skill development training (short-term training and Recognition of Prior Learning) to the prospective candidates through accredited and affiliated training centres/training providers.

After successful implementation of Pradhan Mantri Kaushal Vikas Yojana (PMKVY) during 2015-16, Government has modified its guidelines to make more proactive, transparent and beneficiary oriented. Scheme proactively imparts high employment potential industry relevant courses for prospective candidates. Training providers, including industry, are actively participating as accredited and affiliated training partners/centers in imparting training-cum-placement activities as per National Skill Qualification Framework (NSQF) Norms.

This scheme has also provisions for high standard monitoring of TCs/TPs. Various IT measures and interventions such as Direct Benefit Transfer, Aadhaar linkage of trainers and trainees, Biometric attendance of candidate etc have been ensured. Complete transparency and accountability has been ensured in assessment process by leveraging technology. The assessment agency would adopt various methodologies

such as self-audit reporting, call validations, surprise visits, and monitoring through the Skills Development Management System (SDMS) for continuous monitoring. This scheme has targeted to provide skilling to one crore people (60 lakh under Fresh Training and 40 lakh under RPL) over the four years (2016-2020) with an outlay of ₹ 12,000 crore. Under PMKVY scheme, till now, about 39 lakhs people were trained/ undergoing training. Out of total, about 162891 candidates have been trained in Haryana under Short Term Training (STT) of PMKVY.
