THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI C.R. CHAUDHARY): (a) and (b) Exports have been key source of economic growth of the country by way of creation of employment opportunities in the country and contributing to the growth in Gross Domestic Product.

The Government announced a major relief package for exporters in October 2017 by extending the Advance Authorization (AA)/Export Promotion Capital Goods (EPCG)/100% EOU schemes to sourcing inputs etc. from abroad as well as domestic suppliers. Holders of AA / EPCG and EOUs would not have to pay Integrated Goods and Services Tax (IGST), Cess etc. on imports. Also, domestic supplies to holders of AA/EPCG and EOUs would be treated as deemed exports. During the mid-term review of Foreign Trade Policy in December, 2017, export incentives under Merchandise Exports from India (MEIS) have been increased by 2% across the board for labour intensive MSME sectors leading to additional annual incentive of ₹ 4,567 cr. This was in addition to already announced increase in MEIS incentives from 2% to 4% for Ready-made Garments and Made Ups in the labour intensive Textiles Sector with an additional annual incentive of ₹ 2,743 cr. For Leather and Footwear Articles, an additional benefit of ₹ 749 crore is part of the relief package. Further, incentives under Services Exports from India Scheme (SEIS) have also been increased by 2% leading to additional annual incentive of ₹ 1,140 cr.

CHAUDHARY): (a) and (b) A request was received from the State Government of Maharashtra in November, 2013 for transfer of Central Government salt pan land in Mumbai to the State Government for affordable housing. After consideration of the proposal, the Government of Maharashtra was requested to submit a detailed proposal on the lines of internal policy guidelines to consider transfer of surplus salt land. No such proposal has been received from the State Government.
