The National Archives of India runs a canteen which is located near to the National Archives of India Annexe in a separate building, where tea, coffee and lunch is provided to scholars and staff at reasonable rates.

Digitisation of record and uploading on website by NAI

- 516. SHRI MD. NADIMUL HAQUE: Will the Minister of CULTURE be pleased to state:
- (a) whether the National Archives of India (NAI) has completed the digitisation of its records and its uploading on its website; and
- (b) if so, the details thereof and if not, the time by when digitisation of records and its uploading on website are likely to be completed by NAI?

THE MINISTER OF STATE OF THE MINISTRY OF CULTURE (DR. MAHESH SHARMA): (a) No, Sir.

(b) The digitisation and uploading of the digitised records is a continuous process. So far 16820 digitized records have been uploaded on the search portal.

Vacant posts in Archaeological Survey of India

- 517. SHRI SAMBHAJI CHHATRAPATI: Will the Minister of CULTURE be pleased to state:
- (a) whether in Archaeological Survey of India (ASI) a large number of Group A, B and C posts, to be filled through direct recruitment and promotion basis, are vacant for a number of years affecting the overall functioning;
- (b) if so, the details of sanctioned and vacant Group A, B and C posts in each of last three years;
- (c) whether the Government proposes to take the matter with SSC and UPSC to expedite filling up the vacant post on urgent basis; and
- (d) reasons for not filling the vacant posts as and when they fall vacant to be filled through promotion mode?

THE MINISTER OF STATE OF THE MINISTRY OF CULTURE (DR. MAHESH SHARMA): (a) Yes, Sir. In Archaeological Survey of India (ASI) some of the Group A, B and C posts which are filled up through direct recruitment and promotion basis are lying vacant.

- (b) The details of sanctioned, filled and vacant posts in Archaeological Survey of India (ASI) in the last three years are given in the Statement (See below).
- (c) The ASI has been periodically taking up with UPSC/SSC for expediting the filling up of the vacancies falling under direct recruitment quota and those which are filled up on the recommendations of Departmental Promotion Committee meetings held by the UPSC.
- (d) Filling up of some posts have been pending either due to non availability of eligible candidates in the field of promotion or in some cases the Recruitment Rules in respect of the posts are under revision in consultation with DOPT, UPSC and M/o Law.
