

**Increasing the strength of paramilitary forces**

538. SHRI A. VIJAYAKUMAR: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government has any proposal to increase the strength of paramilitary forces in the country;
- (b) if so, the paramilitary force-wise increase proposed; and
- (c) the target fixed to recruit proposed increase in strength of forces?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI KIREN RIJIJU): (a) and (b) At present two such proposals are under consideration of the Government viz. raising of 9 additional battalions in ITBP and 6 additional battalions in BSF.

(c) Recruitment is an ongoing process. Increased strength/vacancies are notified by the CAPFs from time to time every year to fill up the vacancies. Generally, all recruitments are completed within 1 to 1½ year.

**Complaints of stalking**

539. SHRI TIRUCHI SIVA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) how many complaints of stalking have been registered by women in last three years;
- (b) how many of such complaints have been solved and the perpetrator has been identified by the police; and
- (c) in how many cases the investigation is still going on?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI HANSRAJ GANGARAM AHIR): (a) to (c) As per the information received from National Crime Records Bureau (NCRB), details of State/UT-wise Cases Registered (CR), Cases Charge Sheeted (CCS), Cases Convicted (CON), Persons Arrested (PAR), Persons Charge Sheeted (PCS), Persons Convicted (PCV) and Cases Pending Investigation at the end of the Year (CPIFY) under Stalking for Crimes against Women during 2014-2016, are given in the Statement (*See* below).

‘Police’ and ‘Public Order’ are State subjects under the Seventh Schedule to the Constitution of India. The responsibilities to maintain law and order, protection of life and property of the citizens rest primarily with the respective State Governments.

The State Governments are competent to deal with such offences under the extant provisions of laws.

Ministry of Home Affairs has issued advisories on 04.09.2009, 20.4.2015 and 12.05.2015 on crime against women to all State Governments/UTs. These advisories specifically direct the States/UTs that cases should be thoroughly investigated and chargesheets against the accused persons should be filed within three months from the date of occurrence, without compromising on the quality of investigation. Speedy investigation should be conducted in heinous crimes such as rape, murder etc. The medical examination of rape victims should be conducted without delay. Advisories have been issued asking States/UTs to increase the number of women in police force, compulsory registration of FIRs, women police stations, 24x7 women help desks etc. These advisories are available at [www.mha.nic.in](http://www.mha.nic.in).

### **Safe city plan for women**

540. SHRIMATI SASIKALA PUSHPA: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that Government has mooted 'safe city' plan for women in the country; and

(b) if so, the salient features of these plans and the current status of the plan?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI HANSRAJ GANGARAM AHIR): (a) and (b) Government is planning to implement a 'safe city' project in eight selected cities namely, Delhi, Kolkata, Mumbai, Chennai, Bengaluru, Hyderabad, Ahmedabad and Lucknow on a pilot basis with a view to provide safety to women with funding from Nirbhaya Fund. The Municipal Commissioners and the Police Commissioners of these cities have been asked to submit their detailed proposals by December, 2017.
