Number of workshops and land allotted by SECL to ex-servicemen are given below—

(1) Gevra Project

9 44 Ha. of land including one workshop shed has been allotted to 7 ex-servicemen companies.

(2) Dipika Expansion Project

6.50 Ha. of land has been allotted to Ex-servicemen Companies for their office/workshop.

(b) As per the Memorandum of Understanding signed by Directorate General of Resettlement, Ministry of Defence and Coal India Limited, Coal Subsidiaries will provide working space at prevalent market rates and norms to Ex-servicemen transporters being deployed by them. This includes accommodation, workshops, garages and office.

THE MINISTER OF STATE IN THE MINISTRY OF COAL AND MINES (DR. DASARI NARAYANA RAO): (a) Adequate steps, as stipulated in the approved Environmental Management Plan (EMP) and Project Report (PR) of each mine, are taken by Mahanadi Coalfields Limited (MCL) for back filling of excavated mine voids and rehabilitation of land

The steps include Back filling of the de-coaled area, Leveling of the back filling area, Spreading of Topsoil over the back filled area and Biological reclamation over the back filled area.

(b) The progress of reclamation or rehabilitation of mined out land in MCL is satisfactory as is evident from table shown below:

Rehabilitation of excavated mine is a continuous process. All excavated area cannot be reclaimed/rehabilitated because of technical reasons like movement of men, machinery in the active areas. As the progress is not slow, no remedial measures are proposed.
