THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI ANANTKUMAR HEGDE): (a) and (b) Yes, Directorate General of Training, and National Association of Software Services Companies (NASSCOM) has signed an MoU on 27th April, 2018 in the field of skill development particularly with respect to the re-skilling and up-skilling imperative in areas of new and emerging technologies, such as Artificial Intelligence, Virtual reality, Robotic Process Automation, Internet of Things, Big Data Analytics and 3D Printing.

Under this MoU, following 4 new trades in the emerging technology "Internet of Things" have been introduced in ITIs under Craftsmen Training Scheme from the session August, 2018.

- (c) whether all these centres in Bihar have been established as sub-centres and main operators of centres are working in some other States;
- (d) whether amount is being spent after 40 per cent deduction being made in amount to be paid to sub-centres; and
- (e) if so, details thereof and under which rule the deducted amount is being spent?

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI ANANTKUMAR HEGDE): (a) and (b) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship is implementing a flagship scheme known as Pradhan Mantri Kaushal Vikas Yojana (PMKVY) on pan–India basis. PMKVY enables large number of prospective youth for taking Short Term Training (STT) and Recognition of Prior Learning (RPL) through accredited and affiliated training centres. PMKVY has two components known as Centrally Sponsored Centrally Managed (CSCM) being implemented by National Skill Development Corporation (NSDC) and Centrally Sponsored State Managed (CSSM) being implemented by State Skill Development Missions of the States/ UTs popularly known as State-Engagement Component of PMKVY (2016-20).

Under CSCM component of PMKVY 2016-20, as on 10.07.2018, 1,55,678 candidates have been trained (1,07,700 STT + 42,320 RPL + 743 Special Project)/ undergoing training (4,915) under STT, RPL and Special Project in the State of Bihar. Under the modified PMKVY 2016-20 scheme, placement tracking is mandatory. The placement data is reported within 90 days of certification of trained candidate. As per data reported on SDMS, as on 10.07.2018, 77,448 candidates are certified under Short Term Training of PMKVY 2016-20. The number of candidates certified under Short Term Training of PMKVY 90 days prior *i.e.* 10.04.2018 is 53,175. Out of these candidates, as on 10.07.2018, 26,996 candidates have been placed in various sectors.

Under PMKVY 2016-20, the accreditation and affiliation of training centres are being done through a single window application SMART for imparting skill development training. Under CSCM component of PMKVY 2016-20, as on 10.07.2018, about 7,213 TCs are operational including 253 in State of Bihar. District-wise list of TCs, candidates trained and placed in State of Bihar under STT of CSCM component of PMKVY 2016-20 is given in the Statement (*See* below).

Further, under CSSM component of PMKVY 2016-20, 25% of the funds and corresponding physical targets of PMKVY 2016-20 has been allocated to the States

for the implementation of scheme through State Skill Development Missions. Under this component, after evaluation of proposal received from Bihar Skill Development Mission (BSDM), Government of Bihar, Ministry has given in-principle approval of a total target of 89,664 candidates and corresponding financial allocation of ₹ 138.05 crore for FY 2016-20. Further, an amount of ₹ 36.81 crore has been released during FY 2017-18 to Government of Bihar for the implementation of CSSM component of the Scheme. As on 17th July, 2018, 299 candidates have been enrolled in 65 empanelled training centres.

(c) to (e) As per PMKVY (2016-20) guidelines only first level franchising is allowed and franchisee centres will be given lower priority and it is planned to gradually phase out franchisee agreements. During monitoring visits, it was observed the compliance to scheme guidelines was significantly lower in case of franchisee centres as compared to Training Provider Owned centres. In view of this Ministry had decided in 2017-18 only to provide a pathway for all franchisees to become Training Providers, thus converting franchisee centres under PMKVY into Training Provider Owned centres. Further, no new franchising centre is being allowed under the scheme.
