Government's exit from Air India

- (b) The Government has no such plan to exit Air India altogether.
- (c) The Preliminary Information Memorandum (PIM) for inviting Expression of Interest (EoI) for the Strategic Disinvestment of Air India including its shareholding in Air India Express and AI SATS was issued on 28.03.2018. Accordingly, time was given upto 16.04.2018 for submitting written queries by the prospective bidders to the Transaction Advisor. On receipt of the queries by the Transaction Advisor, clarification/corrigendum to PIM was issued on 01.05.2018.
- (d) and (e) Probable reasons as analyzed by the Transaction Advisor, *i.e*, M/s EY for non receipt of bids, *inter alia*, are GoI 24% stake and corresponding rights, high amount of allocated debt, changes in macro environment, individuals not being allowed to bid, profitability track record and bidders not being able to form a consortium within given time period.
