- (c) whether the rescued children have been rehabilitated or handed over to their parents/guardians/family; and
 - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI HANSRAJ GANGARAM AHIR): (a) and (b) As per the latest available published information with National Crime Records Bureau (NCRB), the year-wise Cases Registered, Kidnapped and Abducted and Recovered/Rescued from the year 2014 to 2016 are as under:—

The latest data pertains to the year 2016.

(c) and (d) 'Police' and 'Public Order' are State subjects under the Seventh Schedule to the Constitution of India. The responsibilities to maintain law and order, protection of life and property of the citizens rest primarily with the respective State Governments. The State Governments are competent to deal with such offences under the extant provisions of laws.

A Standard Operating Procedure (SOP) has been prepared by Ministry of Women and Child Development for tracing of missing children, and has been circulated to all the States and UTs for further dissemination to all other stake holders such as Police, Child Welfare Committees (CWCs), Juvenile Justice Boards (JJBs) etc. This SOP lays down uniform guidelines for expediting the search and rehabilitation of a missing child all over the country.

Contractual workers in NDMC

- 1681. DR. SASIKALA PUSHPA RAMASWAMY: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether New Delhi Municipal Council is hiring workers on contractual basis, if so, details thereof including status of number of workers engaged in different departments of NDMC in last five years;
- (b) whether Government is aware that under Rule 25 (2) (v) (a) of Contract Labour (Regulation and Abolition) Act, 1970 which ensures equal pay for equal work applies to contractual employees;

- (c) if so, reasons for not giving same remuneration or facilities as being given to regular employees, which is violative of principles of natural justice; and
 - (d) whether Government would take steps to bring pay parity between them?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI HANSRAJ GANGARAM AHIR): (a) NDMC has informed that they are not hiring any new workers on contract basis. It has engaged 1087 workers on contractual basis in last five years, details of which are given in Statement.

(b) and (c) The Contract Labour (Regulation and Abolition) Act, 1970 and the rules framed thereunder regulate the employment of contract labour. Rule 25(2)(v) (a) of the Contract Labour (Regulation and Abolition) Central Rules, 1971 provides as under:—

"In case where workmen employed by the contractor perform the same or similar kind of work as the workmen directly employed by the principal employer of the establishment, the wage rates, holiday, hour of works and other conditions of service of the workmen of the contract shall be same as applicable to the workmen directly employed by the principal employer of the establishment or similar kind of work".

The said rule is applicable in case of workmen employed by the Contractor and engaged in work awarded to the said contractor on behalf of the Principal Employer, which is not the case in NDMC.

A well-established Central Industrial Relations Machinery (CIRM) is in place to enforce the Contract Labour (Regulation and Abolition) Act, 1970. The country-wide network of Dy. Chief Labour Commissioners (Central) and Regional Labour Commissioner (Central) under the control of Chief Labour Commissioner (Central) is mandated to settle the complaints/claims of the contract workers in terms of the provision of said Act and Rules framed thereunder.

(d) NDMC has informed that persons engaged on contract basis are paid on the basis of scales of 6th Central Pay Commission (CPC). Revision of the same as per the scales of 7th CPC is under consideration.
