Ministry of Agriculture and Farmers Welfare advises farmers to adopt techniques, such as, *in-situ* moisture conservation, on farm water harvesting through farm ponds, etc., ridge furrow, board bed furrow, promoting agronomic practices, including direct seeded rice through seed drills/drum seeder, use of short duration and stress tolerant varieties of paddy like Sahbhagi Dhan/Swarna Sub-I, Intercropping and mixed cropping with pulses/oilseeds/coarse cereals, spray of drought mitigating chemicals like bio-urea, KCL, KNO3, hydrogel and mulching etc. However, agriculture being State subject, the primary responsibility of imparting training to the farmers and making them aware of various techniques to overcome damage to crops, rests with State Governments.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND FARMERS WELFARE (SHRIMATI KRISHNA RAJ): (a) and (b) At present there is no proposal before the Government to include milk under Price Stabilization Fund scheme. However, the Government has taken the following measures to stem the decline in procurement prices of milk and to reduce stock of Skim Milk powder;

- Increased the import duty of Whey Powder from 30% to 40% vide notification dated 27.03.2018.
- D/o Revenue vide notification dated 13.07.2018 has allowed 10% export incentive under Merchandise Export from India Scheme (MEIS) for all dairy products.
- Advisory to all the States to include supply of milk/milk products of Cooperatives through Mid-day Meal Scheme, Anganwadis under Integrated Child Development Scheme (ICDS), Health schemes, Tribal Hostels and Government/Institutional canteen.
- 4. Advise to all State Governments and State Milk Federations to use Public Distribution System of State Governments to market surplus milk.
- 5. The State Government of Bihar and Rajasthan issued order to provide milk powder to children of Anganwadi centres under ICDS.
- State Governments of Gujarat and Maharashtra have announced to provide subsidy of ₹ 50/Kg for skim Milk Powder.
- A Scheme named "Support to State Cooperative Dairy Federation" has been approved to provide working capital loan to State Cooperatives and Federations with a corpus of ₹ 300 crore
