The State/UT-wise number of ULBs declared as ODF is given in the Statement (See below).

Installation of Doppler Radars in Uttarakhand

- (a) whether it is a fact that even after five years of flash floods of 2013 in Uttarakhand, the Doppler Radars are yet to be installed;
 - (b) if so, reasons for delay;
- (c) whether it is also a fact that the State Government wrote to India Meteorological Department (IMD) and the Ministry of Earth Sciences in 2015, seeking permission to procure Doppler Radars under World Bank funded Uttarakhand Disaster Recovery Project (UDRP); and
- (d) the details of the Automatic Weather Stations (AWS) and telemetric rain gauges to be installed in all 95 blocks in the State?

THE MINISTER OF EARTH SCIENCES (DR. HARSH VARDHAN): (a) Yes, Sir.

- (b) Procurement of three X-Band DWRs in Uttarakhand State is under process.
- (c) Yes, Sir. The State Government has written to India Meteorological Department in May, 2014 regarding procurement of Doppler Radars, Early Warning System, Automatic Weather Stations/Rain Gauges (AWS/ARG) etc. under World Bank funded Uttarakhand Disaster Recovery Project (UDRP). An MoU was signed in September, 2017 between Uttarakhand State Disaster Management Authority, Government of Uttarakhand and India Meteorological Department, Government of India for assisting the State Government in establishing AWS/ARG network.
