Formulation of policy for social media

1350. SHRIMATI SAROJINI HEMBRAM: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) the various steps Government has taken to curb the increasing number of trolling in various social media platforms;
- (b) whether Government is going to formulate any new policy for the social media and its users;
  - (c) if so, the details thereof; and
  - (d) if not, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (COL. RAJYAVARDHAN SINGH RATHORE.): (a) Police and public order are State subjects and prevention, detection, investigation of crime are primarily the responsibility of States. On receipt of complaints from affected person, law enforcement agencies require social media platforms to remove such content or block them from viewing, and take up investigation and other action as per law against the culprits.

(b) to (d) Social media platforms are intermediaries as defined in the Information Technology (IT) Act, 2000. Government has notified the Information Technology (Intermediary Guidelines) Rules, 2011 under section 79 of the IT Act. Social media platforms are required to follow due diligence prescribed in these rules, which inter alia includes informing the users of computer resources not to host, display, upload, modify, publish, transmit, update or share any information that is harmful, objectionable, affects minors and is unlawful in any way. Government will further strengthen these guidelines to address new forms of challenges.
