

Present implementation status of NREGA

2428. SHRIMATI MAYA SINGH: Will the Minister of RURAL DEVELOPMENT be pleased to state:

(a) the present status of implementation of National Rural Employment Guarantee Act(NREGA) district-wise and State-wise;

(b) the number of districts where it has not been implemented but were earmarked to be implemented;

(c) by when it will be implemented in all the districts; and

(d) the details of the hindrance in success of the scheme?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI CHANDRA SEKHAR SAHU): (a) State-wise status of implementation of National Rural Employment Guarantee Act for the years 2006-07 and 2007-08 is given in Statement-I and II respectively (*See below*) District-wise status is being compiled.

(b) NREGA was extended to 200 identified districts in the first phase and has been extended to 130 additional districts in the second phase. At present the Act is being implemented in all these 330 districts.

(c) In accordance with Section 1 (3) of the National Rural Employment Guarantee Act (NREGA), 2005, the Act shall be applicable to the whole of the territory, to which it extends, within a period of five years from the date of its enactment. NREGA was enacted on 7th September, 2005. All districts are to be covered under the Act by 7th September, 2010.

(d) Lack of worksite facilities, delay in wage payments and shortage of staff are some hindrances in the implementation of the Act in some States.
