Jyoti Bima Yojana (PMJJBY) and Pradhan Mantri Suraksha Bima Yojana (PMSBY) to provide life and disability coverage to the unorganised workers for the age group of 18 to 50 years depending upon their eligibility. These converged schemes give coverage of ₹ 2 lakhs on death at premium of ₹ 330/- per annum and coverage of ₹ 2 lakhs on accidental death at premium of ₹ 12 per annum besides disability benefits as per the scheme. These converged schemes are being implemented by Life Insurance Corporation of India. The annual premium is shared on 50:50 basis by the Central Government and the State Governments.

(c) and (d) The casual workers are entitled to benefits as admissible under the relevant labour laws which are enforced by the respective enforcement machinery available under the Central and the State sphere.

Impact of demonetisation on daily wage earners

- 4254. SHRI DEREK O'BRIEN: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:
- (a) whether Government has assessed the impact of demonetisation on daily wage earners and the details thereof and if not, the reasons therefor;
- (b) whether Government takes into cognizance the fact that many such persons who were affected by demonstisation had to migrate or relocate to other States in search of opportunities and the details thereof; and
- (c) whether Government has initiated any schemes which would provide monetary assistance or other opportunities to such persons and the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI SANTOSH KUMAR GANGWAR): (a) to (c) Employment as daily wage earners depends on variety of factors and it is difficult to pin point the degree of impact of demonetisation thereon. There is no such input available with this Ministry.

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI SANTOSH KUMAR GANGWAR): (a) As per the information received from State Governments/Union Territory Administrations, the State-wise number of building workers registered with the State Building and Other Construction Workers' Welfare Boards upto 31.12.2017 (provisional) is given in the Statement (See below).

- (b) and (c) All States have constituted the State Building and Other Construction Workers Welfare Board (SWBs). As per Sections 18 of the Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996, the State Welfare Boards consists of a chairperson, one nominee of the Central Government and other members, not exceeding fifteen, appointed to it by the State Government.
- (d) to (f) The Monitoring Committee, under the Chairpersonship of Secretary (Labour and Employment) was constituted on 09.09.2015 with the following composition:-
 - (i) Secretary (L&E) Chairman
 - (ii) Additional Secretary (L&E) Vice-Chairman
 - (iii) Joint Secretary and DG(LW) Member Secretary
 - (iv) A representative of Chief Labour Commissioner (Central) Member
 - (v) Director/Dy. Secretary, DG(LW) Member Convener.

The Committee interacts with the Principal Secretaries/ Secretaries/Commissioners, Labour of all the States/UTs in meetings to take State-wise stock of and address issues relating to progress/constraints in implementation of the welfare provisions of the BOCW Act and utilization of the cess fund for the purpose. The proceedings of the meetings in the form of minutes are circulated to the States/UTs for follow up action and compliance. The committee has been holding regular meetings. The Committee meetings have been held on 23.11.2015, 06.01.2016, 06.04.2016, 21.07.2016, 20.12.2016, 09.05.2017, 29.08.2017 and 12.12.2017.
