RAJYAVARDHAN SINGH RATHORE): (a) and (b) Sir, the National Sports Federations are responsible and accountable for the overall management, direction, control, regulation, promotion and development (including engagement of foreign coaches/foreign support personnel) of respective sports disciplines. The Government engages foreign coaches/foreign support personnel only for specific sports disciplines as per the approved Long Term Development Plan. The appointment of such foreign coaches/foreign support personnel is done based on the recommendations of a Committee, headed by Director General, Sports Authority of India, which also recommends the remuneration/salary payable to such foreign coaches/foreign support personnel.

THE MINISTER OF FINANCE (SHRI ARUN JAITLEY): (a) to (c) There is no proposal under consideration of Government of India to denationalise Nationalised Banks.

As per data reported by Public Sector Banks (PSBs), the aggregate liabilities of PSBs, as on 31.12.2017, are ₹ 95,92,847 crore. The liabilities include their capital, reserves and surpluses, deposits and borrowings.
