and Kashmir along LoC/IB are shifted to safer places on account of ceasefire violations/cross border firings. They are provided all kinds of basic amenities like water, electricity, medical etc. at the designated safe shelters.

Government has sanctioned construction of 14,460 bunkers, to mitigate the hardships being faced by people living on IB/LOC, due to Cross Border Firing.

Compensation of  $\ref{thmatcharge}$  5 lakh is given to civilian victims of cross border firing along the Indo Pak border. Compensation for housing damages/losses, crop losses or livestock losses, relief for stay at Relief Campus and displacement etc. to those affected by cross border firings are also given at the rates equal to NDRF that are fixed from time to time.

- (b) the details of ex-gratia announced and paid so far, to kins of victims, victim-wise;
  - (c) whether there were repeated intelligence inputs regarding the attack;
  - (d) if so, the reasons for not taking any action on intelligence inputs; and
- (e) the details of action Government has taken against the guilty who ignored the repeated intelligence inputs?

- (b) The Central Government pays ₹ 35 lacs as ex-gratia and another ₹ 20 lacs ex-gratia is paid through the SRE Scheme to the next-of-kin of martyrs. In addition, CRPF, the State in which the individual was serving and his Home State will pay ex-gratia/insurance benefits/risk/welfare funds. Apart from above, the next-of-kin will also be given full salary till the age of superannuation under Liberalized Pensionary Award (LPA) and are also eligible for compassionate appointment as per applicable rules. ₹ 57 lac has been released to the next-of-kin of each of the martyred personnel.
- (c) to (e) Inquiry into the incident has been ordered and is under progress. Disciplinary action will be taken against any individual blamed for any act of negligence.
