of India to provide rural connectivity, by way of a single all-weather road, to the eligible unconnected habitations in the core network. Since inception till January, 2018, the State of Manipur has been sanctioned 1866 road works worth ₹ 4,124.32 crore under PMGSY. The Ministry has released ₹ 1819.475 crore to Manipur under PMGSY till 2nd February, 2018. The State has reported to have completed 1,299 road works by constructing/upgrading 5,912.335 km. road length till January, 2018.

(c) The State of Manipur has already been sanctioned their full entitlement of roads as per the Core Network under PMGSY. The State is now ready for transition to PMGSY-II. The entitlement for PMGSY-II in the State is 325 Km. road length. As per Programme Guidelines, the States are required to update the existing District Rural Roads Plan (DRRP) and submit a copy to the Ministry after due approval of State Level Standing Committee (SLSC) constituted in the State. The State of Manipur has accordingly been advised to update the DRRP and to submit to the Ministry as per the PMGSY-II guidelines.

## Construction of roads under PMGSY in Karnataka

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV): (a) 'Rural Roads' is a State subject and Pradhan Mantri Gram Sadak Yojana (PMGSY) is a one-time special intervention to provide rural connectivity, by way of a single all-weather road, to the eligible unconnected habitations in the core network. 'Village Roads' (VR) and Other District Roads' (ODR) in the rural areas, which are part of the core network are sanctioned and funded for construction of roads under PMGSY.

(b) Since inception till December, 2017, the State of Karnataka has been sanctioned road works measuring length 18,600.545 Km. worth ₹ 4370.51 crore under

PMGSY, against which a sum of ₹3,632.45 crore has already been released to the State for construction of road works.

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV): (a) to (d) The Ministry releases funds to the States on the basis of agreed to Labour Budget (LB), opening balance, pending liabilities of the previous year for the financial year, if any, and overall performance. The Ministry has released ₹ 240093.03 lakhs (as on 31.01.2018) to Telangana for liquidating the pending liability of wage component and for running the programme during FY 2017-18. The fund release to States/UTs for implementation of Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) is a continuous process and Central Government is making funds available keeping in view the demand.
