Construction of dams/barrages on Brahmhani basin

- 305. SHRI PRASANNA ACHARYA: Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:
- (a) the number of dams and barrages constructed/under construction/proposed to be constructed by the Jharkhand Government on the upper stream of the Brahmhani basin including its tributaries and the details thereof;
- (b) whether permission has been obtained from all concerned authorities for those projects and the conditions laid down have been properly followed;
- (c) whether the downstream riparian State of Odisha have been informed/consulted and its consent taken before taking up of the projects; and
- (d) whether the downstream flow of the river has already been affected due to the said projects?

THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (SHRI ARJUN RAM MEGHWAL): (a) to (c) Water being a State subject, water resource projects are planned, constructed, maintained and operated by the respective State Government depending on their priority and resources for meeting various demands. In order to supplement the efforts of State Governments, Government of India provides technical and financial assistance through various schemes and programmes such as Pradhan Mantri Krishi Sinchayee Yojna (PMKSY).

Central Water Commission (CWC) under Ministry of Water Resources, River Development and Ganga Rejuvenation (MoWR, RD & GR) carries out techno-economic appraisal of major (command area more than 10,000 ha.) and medium (command area 2000 to 10,000 ha.) irrigation projects which are planned on Inter-State river/river basins. List of projects of Jharkhand in Brahmhani basin, approved and accepted by Technical Advisory Committee (TAC) is given in the Statement (*See* below). TAC recommends the projects for construction after carrying out due diligence as per the guidelines in vogue.

(d) No study has been carried out to assess the effect of projects on the downstream flow of the river.
