of Ammunition Road Map in respect of certain identified ammunition and procurements thereof. In addition, financial powers to ensure the availability and maintenance of minimum levels of critical ammunition has been delegated to the Armed Forces to meet any emergent requirement and to enable maintain preparedness at all times.

(d) The Government has taken a series of measures to enhance capacity of ordnance factory boards to meet the long term requirement of the armed forces. These include modernization of ordnance factories by replacement/reconditioning of outlived Plant and Machinery to sustain the original capacity, acquisition of modern technology/manufacturing processes for capacity augmentation of existing product mix or creation of capacity for new product, Civil Infrastructure and services *viz.* Production & Services of buildings. Power supply, Water supply, Compressed Air supply etc.

Signing of agreements with other countries

- 170. SHRI K. SOMAPRASAD: Will the Minister of DEFENCE be pleased to state:
- (a) the countries with which India has signed various agreements during the last three years;
- (b) the details of any military or defence agreements signed with the nations during the last three years; and
- (c) the details of any private company in India, producing military or defence tools or equipment?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (DR. SUBHASH RAMRAO BHAMRE): (a) and (b) A list of military or defence related agreements signed with other nations for the last three years (i.e. from 4th February 2015) is given in the Statement (See below).

(c) Since the opening up of Defence industry sector in May, 2001 for 100% manufacturing by Indian private sector including FDI upto admissible cap both subject to licensing, Department of Industrial Policy and Promotion (DIPP) has issued 343 licenses to 206 Indian Companies till November, 2017. Till December, 2017, 69 license companies covering 112 licenses have reported commencement of production.

Replacement of HAL by Reliance Defence in Rafale deal

- 171. SHRI D. RAJA: Will the Minister of DEFENCE be pleased to state:
- (a) whether it is a fact that the country's premier defence manufacturing company Hindustan Aeronautics Ltd. (HAL) was very much involved in the discussions, underway with the French company along with the Defence Ministry on the Rafale deal, but HAL was jettisoned at the last minute, replacing the public sector company by Reliance Defence; and
 - (b) if so, the details thereof and the reasons therefor?

THE MINISTER OF DEFENCE (SHRIMATI NIRMALA SITHARAMAN): (a) and (b) No Public Sector Undertaking (PSU) or Private Sector industry is involved in the Inter-Governmental Agreement with France. In order to meet the 'Critical Operational Necessity' of the Fighter aircraft in the IAF, the Government decided to procure 36 Rafale aircraft through Government to Government route. The Inter-Governmental Agreement (IGA) was signed for supply of direct flyaway 36 Rafale aircraft on 23rd September, 2016. It does not envisage any manufacturing of platforms in India.
