

MMR and IMR of West Bengal

*116. SHRI MANAS RANJAN BHUNIA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) the Maternal Mortality Rate (MMR) and Infant Mortality Rate (IMR) in the different States of the country; and

(b) what is the MMR and IMR in West Bengal and its position in the country?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI ASHWINI KUMAR CHOUBEY): (a) The Registrar General of India, Sample Registration System (RGI-SRS), provides a nation-wide disaggregated data on Maternal Mortality Ratio (MMR) and Infant Mortality Rate (IMR) in the country.

The latest list for MMR was released in the year 2011-13. The details are given in the Statement-I (*See below*).

As per Sample Registration Survey (SRS), 2016 report of Registrar General of India (RGI), Infant Mortality Rate (IMR) of country is 34 per 1,000 live births. State-wise IMR is given in the Statement-II (*See below*).

(b) As per SRS, 2011-13 MMR report, the MMR of West Bengal is 113 per lakh live births and ranks 6th after Kerala, Maharashtra, Tamil Nadu, Andhra Pradesh and Gujarat.

As per SRS, 2016, Infant Mortality Rate of West Bengal is 25 per 1,000 live births and ranks 20 out of 36 States/UTs.
