THE MINISTER OF STATE IN THE DEPARTMENT OF COMMERCE, MINISTRY OF COMMERCE AND INDUSTRY (SHRI JAIRAM RAMESH): (a) to (c), Representations regarding acquisition of land including agricultural land for setting up Special Economic Zones (SEZs) have been received. However, land being a State subject, acquisition of land comes under the purview of the State Governments. Each State acquires land for various purposes under the provisions of State Policies and the Land Acquisition Act of 1894 as amended from time to time. The decision to earmark land of various types for different purposes is taken by the respective State Governments in accordance with the policies laid down by

them. However, the State Governments have been advised that in case of land required for SEZs, first priority should be for waste and barren land and if

necessary, single crop land could be considered. If perforce a portion of double cropped agricultural land has to be acquired to meet the minimum area requirements, especially for multi-product SEZs, the same should not exceed 10% of the total land required for the SEZs. Further, in pursuance of the decisions of the Empowered Group of Ministers (EGOM) on SEZs at its meeting held on 5th April, 2007, the State Governments have been informed on 15th June, 2007 that the Board of Approval will not approve any SEZs where the State Governments have carried out or propose to carry out compulsory acquisition of land for such SEZs after 5th April, 2007. A Group of Ministers under the Chairmanship of Minister of Agriculture has been constituted to consider revised Resettlement and Rehabilitation policy and amendments to the Land Acquisition Act.
