Rehabilitation of children and families of farmers who committed suicide

1645. SHRI RIPUN BORA: Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) whether Government is aware that the children of the farmers, who committed suicide, do not receive support both financial and physical through mental counselling;
- (b) if so, the details of rehabilitation and support extended during the last five years to the families and children of farmers who have killed themselves, to cope with the acute trauma; and
- (c) the details of time-bound proposal of Government to overcome the struggle of minors to get their lives back on main track?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND FARMERS WELFARE (SHRI PARSHOTTAM RUPALA): (a) to (c) State Governments provide relief to families of farmers who commit suicide. As per information available from the States, the details of relief etc. being provided are as follows:—

- State Government of Maharashtra gives *ex-gratia* relief of ₹ 1.00 lakh to the heirs of the deceased farmer. The three norms of eligibility for *ex-gratia* are crop failure, indebtedness and harassment due to inability to pay agriculture related loans.
- The Punjab Government provides ₹ 3.00 lakh compensation to victims' family w.e.f 23.07.2015.
- Government of Andhra Pradesh provides ₹ 5.00 lakh compensation to the
