family members of the deceased farmers. Of this $\stackrel{?}{\underset{?}{?}}$ 1.50 lakh is one time settlement to wipe off loans/liabilities and $\stackrel{?}{\underset{?}{?}}$ 3.50 lakh towards rehabilitation of the family members.

- The Government of Telangana provides *ex-gratia* relief of ₹ 5.00 lakh to the family of the deceased farmer towards rehabilitation and ₹ 1.00 lakh as a one time settlement to wipe off all the liabilities of the family.
- In Karnataka an amount of ₹ 5.00 lakh relief is provided to the family w.e.f. 1.4.2015. The children of the deceased get free education up to post graduation including hostel facility.

The Government is supporting implementation of District Mental Health Programme (DMHP) under the National Mental Health Programme (NMHP) in 517 districts of the country for detection, management and treatment of mental disorders/illness. The DMHP has been restructured to include additional components like suicide prevention services, work place stress management, life skills training and counseling in schools and colleges. Support is also provided for Central/State Mental Health Authorities, Research and Training and for Information, Education and Communication (IEC) activities.

(b) 100% funding was provided to the States/UTs under RKVY by the Central Government as grant till the end of financial year 2014-15. Thereafter, funds have been provided in the ratio of 60:40 between Centre and States (90:10 for eight North-Eastern and three Himalayan States and 100% funding for UTs). The yearwise details of State-wise fund allocation and release to the States under the scheme during last five years is given in the Statement (See below).

(c) to (e) The year-wise inter-State allocation of funds under the scheme is decided on the basis of parameters specified in the scheme guidelines. Hence, there is no provision under the scheme to increase allocation to any State as per their demand. The Budget Estimate (BE) for the scheme for 2018-19 is ₹ 3100 crore which is more than the Revised Estimate (RE) of ₹ 3050 crore for 2017-18.

Central support to agrarian sector

1647. PROF. M. V. RAJEEV GOWDA: Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the existing Centrally Sponsored Schemes under the Ministry and the allocations for each of these schemes during the last five years, year-wise and scheme-wise:
- (b) the sharing pattern for each scheme between States and the Centre during the said period;
- (c) whether there has been a decline in Central contribution to these schemes; and
 - (d) if so, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND FARMERS WELFARE (SHRI PARSHOTTAM RUPALA): (a) and (b) Agriculture is a State subject. However, the Government of India supports the State Governments through various Central Sector and Centrally Sponsored Schemes. Under Centrally Sponsored Schemes implemented by Department of Agriculture, Cooperation and Farmers Welfare (DAC&FW) financial assistance is provided in the sharing pattern of 60:40 between the Centre and the States, 90:10 in case of North Eastern and 3 Himalayan States. For Union Territories the funding pattern is 100% central grant.

The Department of Animal Husbandry, Dairying and Fisheries (DAHD&F) is implementing two Centrally Sponsored Schemes namely- Livestock Health and Diseases Control (LH&DC) and National Livestock Mission (NLM). For 9 components of the LH&DC scheme the sharing pattern between Centre and States is 60:40, for North Eastern and Himalayan States it is 90:10 and 100% central funding for UTs. Under Professional Efficiency Development activities (one of the components of LH&DC) funding pattern is 50:50 for States and 100% for Veterinary Council of India. For National Livestock Mission (NLM) four components are on 60:40 sharing pattern
