Security in the Indian Ocean

SHRIMATI PREMA CARIAPPA:

Will the Minister of DEFENCE be pleased to state:

(a) whether it is a fact that India is playing a major role in ensuring security in the Indian Ocean with the help of other countries and the US wants to have a more active relationship with the Indian Navy in this regard;

(b) if so, whether various officials of US held a series of meetings with Indian Navy including the Navy Chief on a whole range of issues including maritime security in the backdrop of threat of mass destruction; and

(c) whether both countries have felt the need to secure sea lanes which would enable the countries neighbouring these lanes all over world to prosper?

THE MINISTER OF DEFENCE (SHRI A.K. ANTONY) : (a) to (c) A Statement is laid on the Table of the House.

Statement

(a) to (c) India is one of the major littoral States in the Indian Ocean Region (IOR), Recognising its role and responsibilities in maintaining peace and security in the IOR, Indian Navy and Coast Guard carry out regular surveillance, search and rescue etc. and provide assistance to ships/boats in distress. Patrolling along India's International Maritime Boundary Line (IMBL), cooperation with India's maritime neighbours in the field of sharing information on ship movement and platform signature etc. and joint exercises are some other measures for maintaining good order at sea in the region.

India also holds interactions and joint exercises with some other countries including USA. In such interactions, issues of mutual interest including providing security to sea-lanes in the IOR are also discussed.

India and USA have also agreed to the conclusion of a Maritime Cooperation Framework to prevent piracy and other transnational crimes at sea, carry out search and rescue operations, combat marine pollution, respond to natural disasters, address emergent threats etc.
