(c) During the period 2014-17, Bharat Petroleum Corporation Limited (BPCL), Hindustan Petroleum Corporation Limited (HPCL) and Indian Oil Corporation Limited

(d) OMCs have entered into 6 Memorandums of Understanding (MOUs) with Technology providers and State Governments for setting up 2G Ethanol plants.

THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI DHARMENDRA PRADHAN): (a) to (c) The Government has launched Pradhan Mantri Ujjwala Yojana (PMUY) on 01.05.2016. Under the Scheme, deposit free LPG connection is provided to the woman member of a BPL family with cash assistance upto ₹ 1600 per connection. The cost of first refill/hot plate is required to be borne by the beneficiary. Public Sector Oil Marketing Companies (OMCs) provide interest free loan to the beneficiaries who opt for the loan and the same is recovered through the subsidy received upon purchase of refill(s) by the beneficiary.
