## Fake encounters and custodial deaths

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the details of fake encounters and custodial deaths in the country, since 1st April, 2017 till date, State-wise;
- (b) the details of fake encounters and custodial deaths in Uttar Pradesh since1st April, 2017 till date, district-wise; and
- (c) the details of action Government would take to check fake encounters and custodial deaths as per the orders of Supreme Court?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI HANSRAJ GANGARAM AHIR): (a) The number of cases registered by the National Human Rights Commission (NHRC) on the basis of intimations about the deaths in judicial and police custody and the cases registered by NHRC on the basis of complaints received about alleged fake encounter, State-wise from 01.04.2017 to 28.02.2018 is given in Statement-I (See below).

- (b) The number of cases registered by the National Human Rights Commission (NHRC) on the basis of intimations about the deaths in judicial and police custody and the cases registered by NHRC on the basis of complaints received about alleged fake encounter in Uttar Pradesh, District-wise from 01.04.2017 to 28.02.2018 is given in Statement-II (See below).
- (c) As per the Seventh Schedule of the Constitution of India, 'Police' and 'Public Order' are State subjects. It is for the State Government to take action in every crime. NHRC has also intimated that the Hon'ble Supreme Court has emphasized upon the State Governments to ensure investigation of the cases in the light of the guidelines framed by the Commission and approved by the Court.

Notice to NGOs for details of foreign grants

2136. SHRI BHUBANESWAR KALITA: Will the Minister of HOME AFFAIRS be pleased to state :

- (a) whether Government has issued notices to Non-Governmental Organisations (NGOs) to furnish details of their income and expenditure within a stipulated time-frame in respect of foreign grants that they received;
- (b) if so, the total number of NGOs which have received foreign grants and how many of them have responded to the notice; and
- (c) what action is being contemplated by Government against those NGOs which have failed to comply with Government order including denial of renewal of permission under the Foreign Contribution Regulation Act?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI KIREN RIJIJU): (a) to (c) As per section 18 of the Foreign Contribution (Regulation) Act, 2010 (FCRA, 2010) read with Rule 17 (1) of the Foreign Contribution (Regulation) Rules, 2011 every person/association who have received foreign contribution under the Act, shall submit a signed or digitally signed report electronically online in Form FC-4 with scanned copies of income and expenditure statement, receipt and payment account and balance sheet for every financial year within nine months of the closure of such financial year. Accordingly, this Ministry has issued notices from time to time to such associations who have not filed timely Returns/accounts in Form FC-4.

During the year 2016-17, 22,066 Associations have filed accounts/returns in form FC-4. Out of these 17,410 Associations have actually received Foreign Contribution.
