**Vacant posts of teachers in Kendriya Vidyalayas**

2328. DR. V. MAITREYAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether Government has taken steps to appoint teachers to fill the vacant posts in Kendriya Vidyalayas (KVs) in the country;

(b) if so, the details thereof; and

(c) the total number of posts vacant, as on date?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI UPENDRA KUSHWAHA): (a) and (b) Filling up of vacancies is a continuous process and action is taken by Kendriya Vidyalaya Sangathan (KVS) from time to time, as per the provisions of the relevant Recruitment Rules. KVS has informed that 6255 vacancies of teaching staff (Teachers – 6170, Principals-85) were filled up during 2017. Action has also been initiated by KVS for filling up of 4293 teaching posts (Vice Principals – 30, Post Graduate Teachers -1116, Trained Graduate Teachers-2862, Head Masters – 285) through Limited Departmental Examination (LDE). In addition, a Special Recruitment Drive for filling up 546 vacancies of teaching staff of North Eastern Zone has also been conducted during December, 2017. For the year 2017-18 also, KVS has taken advance action for filling up the existing as well as anticipated vacancies through Direct Recruitment/LDE as the case may be.

(c) As on date, 7885 teaching posts are vacant in KVS.

**Dues of Madarasa teachers**

2329. SHRI K. RAHMAN KHAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that over 50,000 Madarasa teachers across the country have not received central component constituting around 75 to 80 per cent of their salaries during the last two years;

(b) whether Government would consider settling the dues at the earliest; and

(c) if so, by when all the dues would be cleared?

DEVELOPMENT (SHRI UPENDRA KUSHWAHA): (a) to (c) Department of School Education and Literacy is implementing an Umbrella Scheme for Providing Education to Madarasas/Minorities (SPEMM) which comprises of two schemes, namely, Scheme for Providing Quality Education in Madarasas (SPQEM) and Infrastructure Development in Minority Institutions (IDMI). SPEMM is completely voluntary/demand driven scheme in nature.

SPQEM provides *inter alia* for financial assistance to support a maximum of three teachers in a madarsa through the State Governments concerned for honorarium of full time Graduate teachers @ ₹ 6000/-p.m. and Post Graduate/B.Ed. teachers @ ₹ 12000/- p.m..

In the financial years 2016-17 and 2017-18, ₹ 120 crore had been allocated to the Scheme for Providing Education in Madarasas/Minorities (SPEMM) in each year, out of which under SPQEM ₹ 106.94 crore, benefiting 20,969 madarsa teachers and ₹ 64.00 crore (till end of February) benefiting 12,518 madarsa teachers have been spent in the years 2016-17 and 2017-18 respectively.

During the Central Grant in Aid Committee (CGIAC) meeting held on 14.01.2016 for the year 2015-16, a decision was taken that only those Madarasas which have U-DISE Codes or an Unique Identity/Registration code given by State Governments would be assisted. Accordingly, the proposals where the State Governments have provided the UDISE codes for the Madrasas are processed as per availability of budget.
