recommendations for a minimum fee to be paid to panel lawyers which was adopted by Central Authority of NALSA in its meeting dated 9th April, 2016. All the SLSA were requested to amend their regulation accordingly. The schedule of the minimum fee for the Subordinate Courts including Tribunals, and also the High Courts as adopted by the Control Authority is as under:-

## (A) Subordinate Courts at all levels including Tribunals

- (i) Drafting of substantive pleading such as Suit, Matrimonial Proceedings such as Divorce, Maintenance, Custody, Restitution etc., Succession, Probate, Memo of Appeal, Revision, Written Statement, Reply, Rejoinder, Replication etc.-₹1,200/.
- (ii) Drafting of Miscellaneous applications such as stay, bail, direction, exemption etc.- ₹ 400/- per application subject to maximum of ₹ 800/-for all applications.
- Appearance-₹ 750/- per effective hearing and ₹ 500/- for non-effective hearing subject to a maximum of ₹ 7500/- (per case).

## (B) High Court

- (i) Drafting of substantive pleading such as Writ Petition, Counter Affidavit, Memo of Appeal, Revision, Reply, Rejoinder, Replication - ₹ 1500/-.
- (ii) Drafting of Miscellaneous applications such as stay, bail, direction, exemption etc.-₹500/- per application subject to maximum of ₹1000/- for all applications.
- (iii)Appearance-₹ 1000/- per effective hearing and ₹ 750/- for non-effective hearing subject to maximum of ₹ 10,000/- (per case).

It was also recommended that the fee structure should be reconsidered by NALSA and All State Legal Service Authorities every three years.

Most of the SLSAs have recently revised their fee in the year 2017.

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI RAJEN GOHAIN): (a) The targets *vis-a-vis* achievements for installation of bio-toilets in coaches by Indian Railways over the years are as below:—

Will the Minister of RAILWAYS be pleased to state:

- (a) the number of lists of officers of North Eastern Railway working on sensitive posts beyond their tenures which have been sent to the Central Vigilance Commissioner by Chief Vigilance Officer of North Eastern Railway during the last three years;
- (b) the various posts of Group 'D', 'C, 'B' and 'A' in vigilance department which come in the list of sensitive posts, as per directions of the Central Vigilance Commission; and
- (c) the maximum tenure of Chief Vigilance Officer working in Railways, the Zone-wise and date-wise details of the officers working on these posts?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI RAJEN GOHAIN): (a) The details of officers working on sensitive posts beyond normal tenures are not required to be sent to the Central Vigilance Commission but the same is monitored by the Vigilance Organisation of Railways itself. However, the number of officers of North Eastern Railway working on sensitive posts beyond their tenures during last three years are as under:—

The guidelines issued in regard to rotation of officers posted on sensitive posts have been followed on North Eastern Railway with the exception of the above officers only who were retained beyond stipulated four years period in administrative interest.

(b) All Gazetted and Non-gazetted posts (except the post of Presenting Officer) in Vigilance Organisation of Railways have been identified as sensitive posts.
