Non-payment of claims under PMFBY

2436. SHRI DEVENDER GOUD T.: Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the premium paid by farmers to various companies under PMFBY, since implementation of the scheme, State-wise and Kharif and Rabi season-wise;
- (b) the details of companies to which premium has been paid by farmers since implementation of PMFBY, State-wise, company-wise and Kharif and Rabi season-wise;
- (c) whether it has come to the notice of the Ministry that some companies are not paying claims in time citing frivolous reasons;
- (d) if so, whether the Ministry will ask IRDA to cancel the licence of such companies; and
 - (e) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND FARMERS WELFARE (SHRI PARSHOTTAM RUPALA): (a) and (b) State-wise/Company-wise details of premium paid by farmers to the insurance companies during Kharif 2016 and Rabi 2016-17 seasons separately under Pradhan Mantri Fasal Bima Yojana (PMFBY) are given in Statement (See below).

(c) to (e) As far as claims are concerned, as on date, claims of ₹ 14433 crore have been approved and about ₹ 12949 crore have been paid to about 112 lakh farmers insured during 2016-17. However, this does not include claims that are outstanding with insurance companies due to exceptional reasons such as delay in receipt of State share of subsidy, discrepancy in yield data, unavailability of farmer account details etc. As most of the claims except some disputed claims have been settled by the insurance companies, there is no proposal under consideration to ask Insurance Regulatory and Development Authority (IRDA) to cancel the license of insurance companies.
