Increase in Haj quota

- 2525. SHRIMATI N.P. DURGA: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) whether any request from the Andhra Pradesh Government has been received to increase the Haj quota by 10,000;
 - (b) if so, the details thereof and the action taken on the proposal;
- (c) the number of people who performed Haj from the country during the last five years, year-wise, State wise;
 - (d) the amount of subsidy given, year-wise; and
- (e) the additional facilities provided or proposed to be provided to Indian Haj pilgrims?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI E. AHAMMED): (a) and (b) Yes. The allocation of the Haj quota to States by the Haj Committee of India is based on the Muslim population. While some States including Andhra Pradesh have sought increase in their quotas, this has not been possible owing to the limit of the total quota given to India.

(e) Every year the Government of India makes arrangements to facilitate the transportation to Saudi Arabia of the 1,10,000 pilgrims going through the Haj Committee of India and facilitates provision of accommodation and other logistical support for them. For efficient management and supervision of Haj arrangements, a large contingent of seasonal local staff, supervisors, data entry operators, drivers and messengers is appointed by Consulate General of India, Jeddah. In addition, Doctors, Nurses and other para-medical staff, Coordinators, Assistant Haj Officers, Haj Assistants and Khadimul Hujjaj are sent from India on short-term deputation to

Saudi Arabia. A hospital in Makkah and branch offices-cum-dispensaries in Makkah and Madina are set up for Haj pilgrims. Medicines provided at these dispensaries and hospital are supplied from India and also procured locally. The Haj Committee of India provides to the pilgrims information regarding confirmation of their seats, travel documents, transportation, accommodation, release of foreign exchange, embarkation points and departure dates etc.
