WRITTEN ANSWERS TO STARRED QUESTIONS

Full-fledged banking functions by Postal Department

- *321. SHRI RAJEEV CHANDRASEKHAR: Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:
- (a) whether the Department of Posts has approached RBI to grant it licence to convert its Savings Account into a full-fledged bank;
- (b) if so, the number of its branches in the country, which would perform such functions, State-wise;
- (c) whether the staff deputed for performing full-fledged banking duties would be paid suitable scales as given to the staff in the public sector banks; and
 - (d) if not, the reasons therefor?

THE MINISTER OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI A. RAJA): (a) No, Sir. The Department of Posts has not approached the Reserve Bank of India to grant it license to convert the Post Office Savings Bank (POSB) in to a full-fledged bank as the POSB is an agency function carried out by the Department of Posts on behalf of the Ministry of Finance under the provisions of Government Savings Bank Act, 1873.

(b) to (d) Do not arise in view of (a) above.

Upgradation of Lengpui airport

- *322. SHRI LALHMING LIANA: Will the Minister of DEVELOPMENT OF NORTH EASTERN REGION be pleased to state:
- (a) whether the State Government of Mizoram has submitted any project proposal for development/improvement/upgradation of Lengpui airport; and
- (b) if so, the details of the project proposal and the reaction of Government thereto?

THE MINISTER OF DEVELOPMENT OF NORTH EASTERN REGION (SHRI MANI SHANKAR AIYAR): (a) Yes, Sir.

(b) In 2003, the State Government of Mizoram had submitted a project proposal to NEC for upgrading Lengpui airport at an outlay ot Rs. 10.99 crores. Rs. 6.58 crore was sanctioned by NEC in 2005 and NEC has released a grant to the State Government of Rs. 5.92 crore as NEC's 90% share of the expenditure. Componentwise details of the project are given at Statement-I (See below).

The State Government has again submitted proposals to NEC for upgrading Lengpui airport during the Eleventh Five Year Plan. Details of these projects are given at Statement-II (See below).

Owing to limited budgetary allocations for NEC, and the fact that Eleventh Five Year Plan proposals are yet to be finalized, as well as huge committed liabilities, on ongoing projects, consideration of these proposals at present stand deterred. Once the Eleventh Plan is finalized, the Ministry of DONER will be approaching the Ministry of Finance for augmentation of NEC resources.

The State Government of Mizoram has also submitted a similar project proposal for upgrading Lengpui airport at an outlay of Rs. 50.93 crore for funding under the Non-Lapseable Central Pool of Resources. Details of the project are given at Statement-III (See below). The NLCPR Committee will consider the proposal on merits, subject to the availability of funds.

MoU for legal migration

*323. SHRI MAHENDRA MOHAN: DR. (SHRIMATI) NAJMA A. HEPTUŁLA:

Will the Minister of OVERSEAS INDIAN AFFAIRS be pleased to state:

- (a) whether his Ministry and the International Organization for Migration signed a Memorandum of Understanding for the project "Regional Dialogue and Facilitating Managed and Legal Migration between Asia and the European Union";
 - (b) if so, the details of this scheme;
- (c) in what manner this would be helpful in reducing illegal migration to European countries;
 - (d) the modalities of legal help to be given to migrant workers; and
- (e) to what extent European Union has responded to management of immigration in their own countries?

THE MINISTER OF OVERSEAS INDIAN AFFAIRS (SHRI VAYALAR RAVI):
(a) to (e) A Memorandum of Understanding (MoU) has been signed between the Ministry of Overseas Indian Affairs (MOIA) and the International Organisation for Migration (IOM) for implementation of the project "Regional Dialogue and Programme on Facilitating Managed and Legal Migration between Asia and the European Union (EU)"

The project is sponsored by European Union (EU) and covers 10 Asian countries (Bangladesh, China, India, Indonesia, Nepal, Pakistan, Philippines, Sri Lanka, Thailand, Vietnam; for some activities Afghanistan) and 5 European countries (Germany, Ireland, Italy, Spain and U.K).

The project is aimed at facilitating development of legal migration, enhancing regional cooperation on legal migration management, reducing irregular migration, enhancing placement capacity amongst recruiting agencies and dissemination of information relating to employment opportunities and procedures to intending emigrants.

The project will seek to promote and facilitate legal migration of Indian workers to the European Union through a wide range of activities including training at the
