Smuggling of poppy powder/poppy husk from Rajasthan

2969. SHRI PARTAP SINGH BAJWA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that poppy powder/poppy husk is being smuggled in large quantity from Rajasthan to other States in the country;
- (b) if so, the details thereof during the last three years and the current year, State-wise;
- (c) whether there has been a demand for imposing a ban on the sale of poppy husk in Rajasthan; and
- (d) the steps taken by Government to impose a ban on the sale of poppy husk and for strengthening the Narcotics Control Bureau to check smuggling of the same?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI HANSRAJ GANGARAM AHIR): (a) and (b) The Drug Law Enforcement agencies have seized Poppy Husk from various states including Rajasthan. During 2015 to 2018 (till January) 5,42,413.51 Kgs. poppy husk has been seized mainly from Rajasthan (205051.13 kg.), Punjab (111019.91 kg.), Madhya Pradesh (94060.75 kg.), Haryana (38774.88 kg.), West Bengal (32751.18 kg.), Jammu and Kashmir (16347.34 kg.) and Uttar Pradesh (14991.91 kg.).

(c) and (d) The Central Government has issued instructions to State Governments including Rajasthan Government under section 74(A) of NDPS Act, 1985 for fully plough back of Lanced Poppy Straw w.e.f. 01.04.2016. Narcotics Control Bureau (NCB) undertakes destruction of illicit poppy/cannabis cultivation on a regular basis.
