(c) the steps taken by Government to take up certification of passion-driven skills of those like carpenters, ironsmiths, masons and agriculturists among others to augment their livelihood opportunities as well as to enable them to become entrepreneurs?

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI ANANTKUMAR HEGDE): (a) and (b) Indian Institutes of Skills (IISs) are being established in the country to enhance training standards beyond the current programmes available in the skill eco-system and to provide 'hands on skills' training to trainees in specialised areas in collaboration with industry catering to local/regional industry requirements. Ministry of Skill Development and Entrepreneurship has requested all State Governments to look into feasibility of making available land in setting up of IISs in different States.

(c) Pradhan Mantri Kaushal Vikas Yojana (PMKVY) is the flagship skill development scheme of Government of India targeting to skill youth from all sections of the society. PMKVY, implemented through National Skill Development Corporation (NSDC), enables youth for taking Short Term Training (STT) and Recognition of Prior Learning (RPL) through accredited and affiliated training provider/training centers. Under RPL, individuals with prior learning experience or skills are assessed and certified. RPL mainly focuses on the individuals engaged in unregulated/informal sectors.

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI ANANTKUMAR HEGDE): (a) Yes Sir, it is fact that the Directorate General of Training (DGT) has implemented "Dual System of Training (DST)" w.e.f. August, 2016 on the similar concept of German Dual Vocational education and training system (Dual VET) in industrial cluster for

automotive components and electronics in the country. Dual System combines practical training in the industry and theoretical knowledge and basics about safety and tools, equipment along with foundation practical conducted in ITI(s) which gives better ITI - Industry linkage to the trainees. DST enables the ITI trainees to have exposure to latest trends in the industry.

Empowerment of informal economy through skill training

- 3013. SHRI SAMBHAJI CHHATRAPATI: Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:
- (a) whether Government has any plan to empower informal economy through skill training to barefoot entrepreneurs;
 - (b) if so, the details of plan being formulated;
- (c) whether the step in store is likely to ease problem of unemployment to some extent; and
 - (d) what are the main areas being identified under the plan?

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI ANANTKUMAR HEGDE): (a) to (d) Presently, Ministry of Skill Development and Entrepreneurship (MSDE) has been implementing Pradhan Mantri Yuva Udyami Vikas Abhiyan (PM-YUVA). The scheme aims to create an enabling ecosystem for Entrepreneurship Development through entrepreneurship education and training across the country in select Institutes of Higher Learning (Universities, Colleges and Premier Institutes), schools, Industrial Training Centers (ITIs) and Entrepreneurship Development Centres (EDCs) for over a period of five years (2017-18 to 2021-22). Additionally, students will get easy access to a robust network of peers, mentors incubators, funds and business services through an online platform. Under the PM YUVA scheme, interested students will be given entrepreneurship education and training, including social entrepreneurship. So far, 239 Institutes of Higher Learning have been empanelled to impart entrepreneurship education throughout the country and entrepreneurship courses have started in 226 Institutes of Higher Learning. Keeping in view the mandate of MSDE, an end to end customized entrepreneurship orientation module has been integrated under the Life Skill Course module in the PMKVY Courses so that every candidate undergoing PMKVY skill training will receive orientation in Entrepreneurship. In ITI courses, the module
