(b) whether Bhakhra Beas Management Board (BBMB) has installed Automatic Gauge Recorders on the agreed sites and whether these recorders have been made operational;

 (c) whether Government intends to give directions to BBMB that Automatic Gauge Recorders already installed on the agreed sites may be made operational at the earliest;

- (d) if so, the details thereof; and
- (e) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (SHRI ARJUN RAM MEGHWAL): (a) Yes, Sir. Rajasthan is one of the major stakeholders in Ravi and Beas river water.

(b) to (e) BBMB in its 208th meeting held on 21.10.2011 finalized 22 sites for installation of Automatic Gauge Recorders which had been mutually agreed by the Partner States. Later, one of the sites was not found feasible and was dropped. Work of installation of Automatic Gauge Recorders on remaining sites has been completed and data being recorded is under validation and testing as the rating curve at these sites are being developed and calibrated before formally put into use.

Supply of water to Rajasthan from BBMB

3508. SHRI RAMKUMAR VERMA: Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:

(a) whether it is a fact that Punjab and Haryana provide short and fluctuating supplies of Ravi, Beas and Sutlej water to Rajasthan:

(b) whether Government intends to give directions to Bhakhra Beas Management Board (BBMB) to ensrure supply of water to Rajasthan as per its share decided in the Technical Committee Meeting of the BBMB;

- (c) if so, the details thereof; and
- (d) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (SHRI ARJUN RAM MEGHWAL):

(a) to (d) Rajasthan is getting its share of Ravi Beas water at Harike which is delivered by Punjab while its share in Sutlej water is delivered partly by Punjab at Harike and partly by Haryana through Bhakra Main Line (BML) Canal. Bhakra Beas Management Board (BBMB) is releasing water from Reservoirs as per the decision taken in the monthly Technical Committee meetings (TCM) represented by the Chief Engineers of Partner States. BBMB has informed that the overall deliveries to Rajasthan out of Ravi-Beas as well as Sutlej waters are more than its share/ requirement and some fluctuation in deliveries is experienced because of two-four days of transition time from reservoir to Rajasthan border and due to change in indents, losses enroute.

The control of Headworks / delivery points from where Rajasthan is getting water is lying either with Punjab or with Haryana. Further, Rajasthan has already filed a Civil Suit in the Hon'ble Supreme Court of India for transfer of control of Headworks from Punjab to BBMB, which is presently under consideration of the Hon'ble Court.

Projects under PMKSY-AIBP in Telangana

3509. SHRI DEVENDER GOUD T.: Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION be pleased to state:

(a) whether it is a fact that eleven projects have been identified in Telangana under PMKSY-AIBP, which are to be completed during the next two years;

(b) if so, the details of each of the eleven projects, so identified; and

(c) the details of irrigation potential, flow of funds, share of State and the Central Government and the present status of each of the above eleven projects?

THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (SHRI ARJUN RAM MEGHWAL): (a) to (c) Eleven irrigation projects of Telangana which were ongoing under PMKSY-AIBP, have been prioritized for completion in phases by December 2019. The status of these projects as. intimated by State Government/CWC including irrigation potential, Central Assistance released, etc. are given in the Statement.
