

Promotion of FPIs in Himachal Pradesh

*307. SHRIMATI VIPLOVE THAKUR: Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the number of food processing units/industries registered and functioning in the country along with the products which are being processed therein, State-wise, including Himachal Pradesh;
- (b) whether there has been a shortage of food processing units, resulting in farmers not getting fair price of their produces in Himachal Pradesh;
- (c) whether Government proposes to set up more food processing units/industries or revive closed food processing units/industries in Himachal Pradesh; and
- (d) if so, the details thereof, unit/industry-wise?

THE MINISTER OF FOOD PROCESSING INDUSTRIES (SHRIMATI HARSIMRAT KAUR BADAL): (a) Details of State-wise and sector-wise registered food processing units/industries as per the latest Annual Survey of Industries, 2014-15, Central Statistics Office (CSO), Ministry of Statistics and Programme Implementation are given in the Statement-I (*See below*).

(b) to (d) Lack of adequate and appropriate supply chain such as storage including cold storage and cold chain facilities, transport and such other backward and forward linkages between the farmers and food processing industries are coming in the way of realisation of better prices of the agricultural produces by the farmers in the country including the State of Himachal Pradesh. To address these issues and to ensure remunerative prices to the farmers for their produces, the Government has been according due emphasis on food processing and preservation/value addition activities all over the country including in the State of Himachal Pradesh. With a view to boost food processing sector, value addition activities and to ensure remunerative prices to the farmers, the Ministry of Food Processing Industries (MoFPI) has been implementing various Central Sector Schemes under PRDHAN MANTRI KISAN SAMPADA YOJANA (PMKSY) with an allocation of ₹6,000 crore for the period 2016-20 co-terminus with the 14th Finance Commission cycle.

The MoFPI does not set up food processing industries on its own in any State/ Union Territory. However, it extends financial assistance in the form of grants-in-aid to set up food processing by entrepreneur, companies, Self Help Groups (SHGs), Farmers Producer Organisations (FPOs) etc. under various schemes. A list of food processing industries set up in the State of Himachal Pradesh with financial assistance of MoFPI is given in the Statement-II.
