Steps to prevent occurrence of forest fires

2767. SHRI HISHEY LACHUNGPA: Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) details of forest fire incidents occuring in different parts of the country in the last three years;
- (b) whether any steps are being planned by Government to prevent the occurrence of forest fires in different parts of the country;
 - (c) if so, the details thereof; and
 - (d) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (DR. MAHESH SHARMA): (a) Forest Fire occurs every year during summer due to various natural and anthropogenic reasons including accumulation of inflammable materials such as dry leaves, twigs, pine needles etc. Forest Survey of India (FSI), Dehradun, disseminates the satellite based forest fire alerts to the State Forest Departments and other registered users whenever forest fires are detected. The data regarding forest fire incidents occurring in different parts of the country is not maintained in this Ministry. However, the details of forest fire alerts issued to all State/

Union Territory Forest Departments by Forest Survey of India, Dehradun (FSI) during the last three years is given in Statement-I (*See* below).

(b) and (c) The Ministry has issued National Action Plan on Forest Fire in April 2018 and circulated to all State/UT Governments for taking appropriate action for effective prevention and management of forest fire accordingly.

The Ministry supports the efforts of State/Union Territory Governments in prevention and control of forest fire by providing financial assistance for various forest fire prevention and management measures. For prevention of forest fire, awareness camps are organized and adequate publicity is done by the State Forest Department as per the plan. Other prevention and control measures includes creation and maintenance of fire lines in forest areas, engagement of fire watchers, creation of water storage structures in forest areas, strengthening of forest infrastructure, procurement of firefighting equipments, soil and moisture Conservation works in high risk areas, incentivizing villages/communities for protection against forest fire etc. under the Centrally Sponsored Forest Fire Prevention and Management Scheme.

The details of fund released to State/UT Governments for various forest protection measures including forest fire prevention and management under the erstwhile Intensification of Forest Management Scheme and the ongoing Forest Fire Prevention and Management Scheme during the last three years (as on 31.12.2018) are given in Statement-II (*See* below).

Checking of pollution in rivers and water bodies in urban areas

2768. SHRI D. KUPENDRA REDDY: Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) whether awareness campaigns were/are being conducted for checking pollution in rivers, dying marine ecosystems and degradation of environment in urban areas;
 - (b) if so, the details thereof; and
- (c) measures being taken towards reducing water pollution in rivers especially in urban areas?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (DR. MAHESH SHARMA): (a) and (b) Ministry of Environment, Forest and Climate Change (MoEF&CC) is implementing Environment Education, Awareness and Training scheme with an objective to promote environmental awareness among all sections of the society and to mobilize people's participation for conservation of environment. On the occasion of the World Environment Day, 2018, which was hosted by India, a campaign on the theme "Beat Plastic Pollution" was undertaken by MoEF&CC from 23rd May, 2018 to 10th June, 2018. The campaign included cleaning up of 24 identified beach stretches and 24 identified riverine stretches in various States with the involvement of school children, eco-club schools and general public including Government officials. On the above occasion, mini marathons were organized in Delhi and also in four locations in the country; namely, Bengaluru, Bhubaneswar, Shillong, and Gandhinagar which involved participation of large numbers of school children and general public. Awareness about various environmental issues including pollution in rivers, marine ecosystems and degradation of environment in urban areas was also undertaken under National Green Corps programme of the Ministry.
