(b) and (c) Available literatures and WHO's Reports *viz.* Electronic Nicotine Delivery Systems (2014) and Electronic Nicotine Delivery Systems and Electronic Non-Nicotine Delivery Systems (ENDS/ENNDS) (2016) ascertain the harmful health effect of ENDS including e-cigarettes. There is no proposal to issue similar advisory for conventional paper rolled cigarettes in this Ministry as the same are governed under Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce. Production, Supply and Distribution), Act, 2003.

## New AIIMS coming up across the country

2982. SHRI NARESH GUJRAL: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the total number of AIIMS coming up in the various parts of the country and by when will they be functional and details thereof; and
- (b) what would be the total requirements of doctors to run these new hospitals?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI ASHWINI KUMAR CHOUBEY): (a) 21 new AIIMS are coming up in various parts of the country. Six new AIIMS in Patna (Bihar), Raipur (Chhattisgarh), Bhopal (Madhya Pradesh), Bhubaneswar (Odisha), Jodhpur (Rajasthan) and Rishikesh (Uttarakhand) are functional.

15 new AIIMS have been announced. Time-frame for completion and other details of new AIIMS are given in the Statement (*See* below).

(b) 933 post of doctors have been sanctioned for each of 960 beded new AIIMS.
