## Nikshay Poshan Yojana

2992. SHRIMATI VANDANA CHAVAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the salient features of the Nikshay Poshan Yojana;
- (b) the total amount allocated and transferred to patients under this scheme;
- (c) the percentage of registered TB patients who have submitted their bank account details;
- (d) the percentage of registered TB patients across the country who have received the cash transfer so far, month and State-wise;
- (e) the impediments faced by TB patients to get the DBT transfer in their bank accounts; and
  - (f) the steps Government has taken to ensure universal coverage of the scheme?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI ASHWINI KUMAR CHOUBEY): (a) The salient features of Nikshay Poshan Yojana (NPY) are as follows:—

- 1. All TB patients notified are entitled for NPY benefit at the rate of ₹ 500/- per month for nutrition support till completion of treatment.
- 2. Benefits under the scheme are provided directly into bank/postal account of TB patients.
- All TB patients notified on or after 1st April 2018 and all existing TB patients on treatment are eligible for NPY benefit.
- All notified TB patients whether in public or private sector are entitled for NPY benefit in all States/UTs regardless of their socio-economic status.
- (b) The Government has allocated ₹ 600 crores for Nikshay Poshan Yojana in the budget of 2018-19. As on 07.01.2019, ₹ 110.05 crores has been transferred to TB patients under this scheme.

- (c) As on 7th January 2019, nearly 52% registered TB patients have submitted their valid bank account details.
- (d) As on 7th January 2019, 45% beneficiaries *i.e.* out of 21.16 lakh eligible beneficiaries, 9.47 lakh beneficiaries have received the benefit under the scheme. Details indicating number of beneficiaries who have received the benefits, month-wise and State-wise are given in the Statement (*See* below).
- (e) Invalid or dormant bank accounts or holding of account in a bank which is yet to be integrated with PFMS (Public Finance Management System) are a few challenges being faced in scheme implementation.
- (f) The scheme is universal in nature and is under implementation in all the States/UTs. The scheme entitles all notified TB patients whether in public or private sector to get NPY benefit regardless of their socio-economic status. The Government has taken various measures to expedite the progress under the scheme such as:—
  - The Ministry has provided detailed guidance to the States/Union Territories (UTs) on how DBT is to be operationalized. States/UTs have been given different payment options as per their convenience for either making payment directly through Public Financial Management System (PFMS) or through the Nikshay PFMS interface.
  - Flexibility of providing the benefit through existing bank account of a blood relative has also been given. State has also been advised to facilitate opening of zero balance accounts for TB patients, if necessary, under the Pradhan Mantri Jan Dhan Yojana (PMJDY) and Indian Postal Bank.
  - The Ministry is regularly monitoring the implementation of this scheme and promptly addressing the challenges identified by the States/UTs.
