THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI ASHWINI KUMAR CHOUBEY): (a) to (c) Under Health Minister's Discretionary Grant (HMDG) Scheme, financial assistance up to a maximum of ₹ 1,25,000/- is provided to the eligible patients to defray a part of the expenditure on hospitalization/treatment in Government hospitals for life threatening diseases such as Cancer, and that of Liver, Kidney, Heart etc. For availing the benefit under the scheme, application in the prescribed proforma filled in by the treating doctor/Head of Department and countersigned by the Medical Superintendent of the treating hospital is required to be submitted. The broad criteria and process for providing financial assistance under HMDG is given in the Statement (See below).

Broad criteria and procedure for sanctioning grants under Health Minister's

Discretionary Grant (HMDG)

- Only those persons having annual family income up to ₹ 1,25,000/- and below are eligible for financial assistance under the scheme.
- (ii) Central as well as State Government/UT Administration employees are not eligible for grant under rules.
- (iii) Reimbursement of expenditure already incurred on treatment is not permissible.
- (iv) Recurring expenditure is not permissible.
- (v) Financial assistance is not admissible for T.B. cases for which free treatment is available under National T.B. Control Programme.
- (vi) Financial assistance is provided to patients for taking treatment in Government hospitals only.
- (vii) Application in the prescribed proforma duly filled in by the treating Doctor/Head of Department and countersigned by the Medical Superintendent of the Hospital from where the patient is receiving the treatment, is to be submitted to the Department of Health and Family Welfare.
- (viii) Income Certificate in original from the Revenue Authority concerned showing occupation and monthly/yearly income of the applicant and his/her family members from all sources have to be furnished along with the application form.
