THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI D. PURANDESWARI): (a) to (c) No proposal regarding setting up of a new Central University in Darjeeling is, presently, under consideration of the Government. However, subject to approval by Parliament, a Central Tribal University proposed to be established with its headquarters at Amarkantak shall have powers to establish such number of its regional centres, *viz.* off-campuses constituted by the University and functioning as part of the University, in various tribal areas of the country as are, in the opinion of the University, necessary for furtherance of its objects. Resources permitting, during the Eleventh Plan, the proposed University could, thus, establish its off-campus at Darjeeling.

(c) and (d) Yes, Sir. The Department of Space has informed that it is able to recruit only about 65% of the requirement of Scientists/Engineers during the last few years.

In order to mitigate the problem of acute shortage of quality human resource for Indian Space Research Organization (ISRO), the Government has approved setting up of Indian Institute of Space Science and Technology (IIST) near Thiruvananthapuram as a centre of excellence in education offering under-graduate, post-graduate, doctoral and post-doctoral positions in Space Science, Space Technology and Space Applications with customized curriculum meeting high technology requirements of ISRO.
