Introduction of Aam Aadmi Bima Yojana in all States

1067. SHRI K. SOMAPRASAD: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) whether Aam Aadmi Bima Yojana (AABY) has been introduced in all the States, if so, the details of enrollment from each States till now; and
- (b) the details of benefits distributed among the enrolled beneficiaries from the State of Kerala, the details thereof year-wise?

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI SANTOSH KUMAR GANGWAR): (a) With effect from June 2017, Aam Aadmi Bima Yojana (AABY) has been converged with Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY)/ Pradhan Mantri Suraksha Bima Yojana (PMSBY). Post convergence, the Converged PMJJBY/Converged AABY scheme is operational in those States which have opted for convergence. As on date, 16 States have opted for the converged scheme. It provides insurance cover to all unorganised workers between the age of 18 years to 50 years, living below and marginally above the poverty line. For the existing beneficiaries in the age group of 51-59 years, the old AABY scheme will continue. The details of enrolment for the converged scheme during 2018-19 are given in the Statement (See below).
