**GOVERNMENT BILLS — Contd.**

**The Constitution (Scheduled Tribes) Order (Third Amendment) Bill, 2019**

MR. CHAIRMAN: Hon. Members, there seems to be some communication gap and misunderstanding. So, I am not proceeding with the Consumer Protection Bill, 2018. Now, Shri Jual Oram to move a motion for consideration of the Constitution (Scheduled Tribes) Order (Third Amendment) Bill, 2019.

**जनजातीय कार्य मंत्री (श्री जुएल ओराम):** महोदय, मैं प्रस्ताव करता हूँ:

"कि अरुणाचल प्रदेश राज्य के संबंध में अनुसूचित जनजातियों की सूची में कतिपय समुदायों को शामिल करने के लिए संविधान (अनुसूचित जनजाति) आदेश, 1950 का और संशोधन करने वाले विधेयक को पुरः स्थापित करने की अनुमति दी जाए।"

MR. CHAIRMAN: Motion moved. मंत्री जी, आपको कुछ कहना है, लेकिन भाषण नहीं दीजिएगा।

**श्री जुएल ओराम:** सभापति जी, इसमें कुछ नहीं है, इन्हीं नागा ट्राइब्स के बदले में तीन-चार ट्राइब्स को स्पेसिफिक नाम दिया जा रहा है। इसके अलावा और कोई चेंज नहीं है।

MR. CHAIRMAN: Now, the question is:

"That the Bill further to amend the Constitution (Scheduled Tribes) Order, 1950, for inclusion of certain communities in the list of Scheduled Tribes in relation to the State of Arunachal Pradesh, be taken into consideration."

*The motion was adopted.*

MR. CHAIRMAN: Now, we shall take up Clause-by-Clause consideration of the Bill.

*Clause 2 was added to the Bill.*

*Clause 1, the Enacting Formula and the Title were added to the Bill.*

MR. CHAIRMAN: Now, Shri Jual Oram to move that the Bill be passed. I only suggest you to mention as to what those three tribes are. You just mention it in one line because the media and others may misunderstand it.

श्री जुएल ओराम: सभापति जी, एक omission of 'Abor' है; then, 'Tai Khampiti' instead of 'Khampiti' है और insertion of Mishmi-Kaman (Miju Mishmi), Idu (Mishmi) एडिशनल है।

सभापति जी, सीरियल नं. 9 पर Monpa, Memba, Sartang and Sajolang (Miji) है। उसके बाद सीरियल नं. 5 में Tangsa, Tutsa, Nocta and Wancho हैं, instead of Naga tribe.

**The National Institutes of Food Technology, Entrepreneurship and
