- (iv) Auditing Standards have been issued and States have been advised to establish independent Social Audit Units, conduct Social Audit as per Audit of Scheme Rules, training of Village Resource Persons for conducting Social Audit etc.
- (v) A path breaking initiative for improved planning, effective monitoring and greater transparency with the use space technology for geo-tagging of MGNREGA assets was launched.

## MGNREGA in Gujarat

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV): (a) to (d) Mahatma Gandhi National Rural Employment Guarantee Act, 2005 (MGNREGA) is a demand driven wage employment Scheme, hence no State/UT- wise allocation of fund is made. The Ministry releases funds to the State/UT based on the basis of the agreed to Labour Budget, opening balance, pending liabilities of the previous financial year, if any, and overall performance. Fund release to States/UTs is a continuous process and Central Government is committed in making funds available keeping in view the demand for work. State/UT-wise details of Central fund released under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) during the last three years *i.e.* 2015-16, 2016-17 and 2017-18 are given in the Statement (*See* below). The Ministry seeks additional fund for MGNREGS as and when required for meeting the demand for work on the ground.
