

Condition of Government hospitals in Chhattisgarh

†*23. SHRI RAM VICHAR NETAM: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether the condition of Government hospitals in Chhattisgarh has improved during the last three years, if so, the details thereof;
- (b) whether Government has taken steps for modernisation/upgradation of hospitals, especially hospitals of rural areas in the country;
- (c) if so, the details thereof, region-wise in Chhattisgarh; and
- (d) if not, the reasons therefor?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI JAGAT PRAKASH NADDA): (a) to (c) Public Health and hospitals being a State subject, the primary responsibility of taking appropriate measures for improving the condition of Government hospitals, lies with the State Government. The State of Chhattisgarh has reported undertaking the activities to strengthen public health facilities in last three years, the details of which are given in the Statement-I (*See below*).

Under the National Health Mission (NHM), Government of India has been supporting all the States/UTs, including Chhattisgarh, financially and technically, based on their Programme Implementation Plans for strengthening their health care system, including strengthening of public health facilities. Various measures taken to improve the condition of Government hospitals in Chhattisgarh during FYs 2015-16, 2016-17 and 2017-18 under NHM in addition to measures reported by State under the Statement-I are given in the Statement-II (*See below*) and District-wise details of infrastructure works are given in the Statement-III (*See below*).

Statement-I***Details of Activities undertaken by the State of Chhattisgarh to Improve Condition of Hospitals***

1. 22 District Hospitals have been selected to develop and improve as per Indian Public Health Standard (IPHS) norms in a phased manner and funds are sanctioned by the Government for the same. Hence, Human Resource, infrastructure and equipments are being developed as per IPHS norms.

2. Kayakalp program *i.e.* "Swachh Asptal Yojna", is being implemented in the Govt. Hospitals and health centers in the state since 2015. Due to Kayakaip program, cleanliness, sanitation and hygiene and infection control practices have been improved. Perception and faith in Government Hospitals among public has been changed and improved. Patient satisfaction level has been also increased. Government hospitals and health centers participation in Kayakalp programme is being increasing every year.

NPA's of Banks affecting credit expansion

*24. DR. K.V.P. RAMACHANDRA RAO: Will the Minister of FINANCE be pleased to state:

(a) whether attention of Government is drawn to the newspaper reports that NPAs have become a burden on the Banks and are affecting liquidity and credit expansion;

(b) if so, the details thereof;

(c) the quantum of NPAs in banking system as on date and the amount of loans written off during the last three years; and

(d) whether Government has any strategy to curtail these NPAs and take sufficient caution regarding these NPAs?

THE MINISTER OF FINANCE (SHRI PIYUSH GOYAL): (a) to (d) As per Reserve Bank of India (RBI) data on global operations, the aggregate gross advances of Public Sector Banks (PSBs) and Scheduled Commercial Banks (SCBs) increased from ₹ 18,19,074 crore and ₹ 25,07,885 crore respectively as on 31.3.2008 to ₹ 52,15,920 crore and ₹ 68,75,748 crore respectively as on 31.3.2014. As per RBI inputs, the primary reasons for spurt in stressed assets have been observed to be, *inter-alia*, aggressive lending
