The responsibility of setting up of Blood Banks lies with State Governments. The policy of Government of India is to have at least one blood bank per district. However given the fact that due to various administrative reasons, State Governments carve out new districts periodically, it is difficult to always maintain the ratio of one blood bank per district. In the case of districts not having blood banks, their needs are met by neighbouring districts.
