Out of these, 13 KGBVs are reported to be operational in the State.

Arts and commerce streams in Kendriya Vidyalaya, Pithoragarh

ALI ASHRAF FATMI): (a) and (b) No proposal for opening of Arts and Commerce streams at Kendriya Vidyalaya (KV), Pithoragarh has been received by Kendriya Vidyalaya Sangathan (KVS) either from KV, Pithoragarh or from the Regional Office of KVS, Dehradun. However, Arts stream was sanctioned for the school during the current year, but the sanction had to be withdrawn' due to nonavailability of required number of class rooms.

Poverty as the reason for drop out

(a) whether it is a fact that one reason of giving up study by the children under Sarva Shiksha Abhiyan is poverty;

(b) if so, the efforts being made by Government so that the children may not give up their study midway;

(c) whether complaints have been received regarding the arrangement of providing mid-day meals;

(d) if so, the steps taken for redressal of these complaints; and

(e) the steps taken by Government for successful implementation of the schemes like Sarva Shiksha Abhiyan And Kasturba Gandhi Balika Vidyalaya?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) and (b) Proverty is one of the various socio-economic and school related factors that affect drop-outs.

A number of schemes are being implemented to reduce drop-out rates and universalize elementary education, the main ones being Sarva Shiksha Abhiyan, Mid-day Meal Scheme and the Kasturba Gandhi Balika Vidyalayas.

(c) and (d) Instances of inferior quality, unhygienic, sub-standard meals and other irregularities brought to the notice of Government are ivestigated through respective State Government/UT Administrations. In order to avoid recurrence of such complaints, Government has prescribed a comprehensive and elaborate mechanism for monitoring and supervision of the Mid-Day Meal Scheme.

At national level, National Steering-cum-Monitoring Committee is monitoring and reviewing the implementation of MDM Programme. Similarly, at State level, a State level Steering-cum-Monitoring Committee reviews and monitors implementation of the programme.

(e) For successful implementation of the Sarva Shiksha Abhiyan and Kasturba Gandhi Balika Vidyalaya programmes, a regular and intensive monitoring system has been put in place to ensure proper implementation.

Shortage of teachers
