THE MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION (SHRI JAYANT SINHA): (a) and (b) Indira Gandhi International Airport, Delhi, Chhatrapati Shivaji Maharaj International Airport, Mumbai, Kempegowda International Airport, Bengaluru, Rajiv Gandhi International Airport, Hyderabad, Cochin International Airport, Cochin, Durgapur Greenfield Airport in West Bengal and Kannur International Greenfield Airport in Kerala in the country are being maintained by private players. Introduction of PPP at these airports has led to significant improvement in the infrastructure, rise in collection of revenues and airport service quality, etc. These airports constantly figure among the top five airports in the global ranking in their respective categories.

- (c) 129 airports are being maintained and operated by Airports Authority of India (AAI). Details are given in the Statement (See below).
- (d) Yes Sir. Union Cabinet in its meeting held on 08.11.2018 accorded 'Inprinciple' approval for leasing out six airports of AAI viz. Ahmedabad, Jaipur, Lucknow, Guwahati, Thiruvananthapuram and Mangaluru for operation, management and development under PPP mode through PPPAC.
