#### **MoUs signed during Vibrant Gujarat Summit**

320. SHRI SAMBHAJI CHHATRAPATI: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:

(a) the year-wise details of MoUs concerning medium and small enterprises signed during Vibrant Gujarat Summit since 2014;

(b) whether some of the MoUs concerning micro, small and medium enterprises signed during the Summit have been implemented on ground during the last four years; and

(c) if so, the details thereof and how many persons have earned employment in such enterprises?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI C. R. CHAUDHARY): (a) to (c) The Government of Gujarat has been organizing Vibrant Gujarat Global ' Summit, a biennial investors' summit since 2003. The summit provided a forum for discussion on Global, National and State-level agendas with a sharp focus on all round economic development for a 'New India'. The 9th edition of the summit was organised from the 18th to 20th January 2019 in Gandhinagar, Gujarat. This year's summit witnessed participation from 42,000 delegates from across the globe. The vibrant Gujarat summit witnessed intensive interaction on bilateral and multilateral discussion on Ease of Doing Business, Make in India achievements, Make in India 2.0, Industrial Corridors, Industrial Park and Industry 4.0, Infrastructure Development,

Startups, Skill Development etc. In addition to the flagship events, the summit also witnessed the launch of a completely new set of forums aimed at diversifying the nature of knowledge sharing and intensifying the level of networking between participants. The summit also provide opportunities for various stake holders to connect with each other, understand each other's perspective and expectations and work towards mutually beneficial goals.

During the Vibrant Gujarat summit, a number of MoUs have been signed since 2014 in various sectors including Micro, Small and Medium Enterprises (MSMEs). However, the details of these MoUs are not centrally compiled.

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI C. R. CHAUDHARY): (a) and (b) No such study has been conducted by the Government.

(c) No such proposal to conduct study on impact of e-Commerce business on the retail general market in the country is under consideration of the Government at present.
