## High incidence of online abuse

- 340. DR. VIKAS MAHATME: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government has taken any steps to deal with the cases of online abuse and stalking, particularly the use of Artificial Intelligence (AI) softwares to detect abuse;
  - (b) if so, the details thereof;
- (c) whether there exists any system for women and children to register complaints of them being subject to online abuse, if so, the number of complaints registered during the last three years; and
- (d) whether Government is taking any action to eliminate such mishappenings in future?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI HANSRAJ GANGARAM AHIR): (a) and (b) "Police" and "Public Order" are State subjects and prevention, detection, investigation of crime is the responsibility of States. Many of the tools such as speech recognition, face recognition, CCTV feeds etc. use Artificial Intelligence; and law enforcement agencies utilize such tools and technology as per their operational needs. Further, use of latest tools and technology by law enforcement agencies to curb crimes is an ongoing process.

(c) and (d) The Government has made operational the online cyber crime reporting portal, *www.cybercrime.gov.in* to enable complainants to report complaints pertaining to Child Pornography/Child Sexual Abuse Material, rape/gang rape imageries or sexually
